### Uniform System for Tattoos

Letter stands for the year born - The letters I, O, Q & V are not used

D = 1994, E = 1995, F = 1996, G = 1997, H = 1998, J = 1999, K = 2000  
L = 2001, M = 2002, N = 2003, P = 2004, R = 2005, S = 2006, T = 2007

Examples: N12 = a calf born in 2003 and was the 12th calf born that year. R1 = first calf born in 2005
